EXHIBITOR INFORMATION RULES COMMON TO ALL THE SHOWS

These horse shows are conducted in accordance with the rules of USEF (USAE). The official rulebook of USEF (USAE) will prevail for all the shows. This combined prize list is based on rules of the current rulebook and the handbook of the Arabian Horse Association, where they apply respectively; any changes or corrections of rules will automatically become a part of this combined prize list. Each participant in any of these shows is responsible for knowledge of, and is subject to the USEF (USAE) rules. Questions not covered by USEF (USAE) or AHA rules shall be decided by the show committee and its decisions final.

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF (USAE) RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. THESE SHOWS WILL BE RUN IN CONFORMANCE WITH THE CODE OF ETHICS OF THE INTERNATIONAL ARABIAN HORSE ASSOCIATION.

MANAGEMENT

The Show Committees, the sponsoring associations, their agents, and employees will not be held responsible for any accidents which may occur to or by any rider, driver, groom attendant, spectator, animal or equipment while on the show grounds.

Show Managements will be charged with the responsibility of enforcing all USEF (USAE) and AHA rules. Special emphasis will be placed on the rules pertaining to the retention of natural action; expressly hoof length, weighted shoes, pads, or action brought about by these or similar artificial appliances. Leg chains, rattlers, or other artificial appliances on a horse's legs while on the show grounds will be immediate cause for removal from the Show, and all monies, ribbons, and trophies shall be forfeited.

The Managements reserves the right to change judges from classes

The Show Managements also bears the responsibility to aid the judges in avoiding contact with exhibitors or their agents before and during the show.

If any exhibitor has made false statements regarding an animal or article exhibited, or if any exhibitor shall attempt to interfere with the judges in the performance of their duties, he or she shall be excluded from exhibiting. Any act of discourtesy or disobedience to the officials on the part of the owner, rider, groom, exhibitor, or driver shall disqualify the horse from being judged. The managements reserve the right to remove any of the aforementioned without being liable for compensation or damages.

The Show Managements reserves the right to decline to receive any entry, and to return any entry fee(s) and/or stabling charges before or during the show without being liable for any compensation.

No persons will be allowed in the ring except participants in the class, judge, assistants, and show photographer. Attendants will be allowed only after being called by the judge or ringmaster.

No exhibitor shall approach a Judge with regards to a decision unless they FIRST obtain permission from the Steward who shall arrange an appointment with the Judge.

MEMBERSHIP

AHA MEMBERSHIP

EACH PARTICIPANT (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS HALTER HANDLERS, AND THE PERSON(S) SIGNING THE ENTRY BLANK) AT AN AHA RECOGNIZED SHOW MUST BE A MEMBER OF AHA OR PAY A \$15.00 SINGLE EVENT MEMBERSHIP FEE PER PERSON

PLEASE NOTE: AHA membership is required for showing at the Regional show

WHEN A FARM, RANCH, SYNDICATE, PARTNERSHIP, CORPORATION OR OTHER BUSINESS ENTITY LISTED AS RECORDED OWNERS ON THE REGISTRATION PAPERS, THE SAME AHA MEMBERSHIP IS REQUIRED

PARENTS SIGNING THE TRAINER LINE FOR JUNIOR EXHIBITORS NEED NOT BE A MEMBER, HOWEVER THEY MUST SIGN PARENT NEXT TO THEIR SIGNATURE.

USEF (USAE) MEMBERSHIP -

LIFE, SENIOR, ACTIVE JUNIOR AND ACTIVE MEMBERS SHALL BE ELIGIBLE TO PARTICIPATE IN ALL CLASSES AT REGULAR MEMBER COMPETITIONS, COMBINED TRAINING/EVENTING COMPETITIONS AT PRELIMINARY LEVEL OR ABOVE AND COMBINED DRIVING COMPETITIONS AT INTERMEDIATE LEVEL OR ABOVE, AND DRESSAGE AND VAULTING COMPETITIONS AND ENDURANCE RIDES PROVIDED THE RESPECTIVE BREED/DISCIPLINE DUES OR BREED/DISCIPLINE CATEGORY FEE HAS BEEN PAID. A NON-MEMBER MAY PARTICIPATE AS A HANDLER, RIDER, DRIVER, OWNER LESSEE, AGENT, COACH OR TRAINER AT REGULAR MEMBER COMPETITIONS, COMBINED TRAINING EVENTS, DRESSAGE COMPETITIONS AND COMBINED DRIVING COMPETITIONS UPON PAYMENT OF A \$20.00 REGISTRATION FEE AND A \$5.00 BREED/DISCIPLINE CATEGORY FEE FOR EACH BREED DISCIPLINE. PARTICIPANTS IN THE FOLLOWING CLASSES ARE EXEMPTED FROM THIS REQUIREMENT OF THIS RULE; 1) LEADLINE; 2) EXHIBITIONS, 3) GAMES AND RACES AND 4) CLASSES FOR 4-H MEMBERS; 5) WALK TROT AND ACADEMY CLASSES (Academy classes are classes limited to horses used regularly in a lesson program.); 6) USDF INTRODUCTORY LEVEL TESTS, PAS DE DEUX AND QUADRILLE CLASSES. ALSO EXEMPTED FROM THIS REQUIREMENT ARE CITIZENS OF OTHER NATIONS WHO ARE MEMBERS IN GOOD STANDING OF THEIR NATIONAL FEDERATION, 7) USEF (USAE) BEGINNER NOVICE DIVISION AND 8) ASSISTANT HANDLERS IN DRESSAGE SPORT HORSE BREEDING CLASSES AND 9) CITIZENS OF OTHER NATIONS WHO ARE MEMBERS IN GOOD STANDING OF THEIR NATIONAL FEDERATIONS AND, IN THE CASE RIDERS, DRIVERS OR VAULTERS COMPETING IN DISCIPLINES RECOGNIZED BY FEI, IN POSSESSION OF A FOREIGN COMPETITORS LICENSE TO COMPETE IN NATIONAL COMPETITIONS WHICH HAS BEEN ISSUED BY THE FEDERATION (See Article 807.4 of the Federation rules).

If you can not present your membership card when picking up your entries, a Membership Affidavit must be signed.

GENERAL

ADMISSION TO ARENA No person permitted in arena during classes except judges, assistants and exhibitors and show photographer. Headers (wearing a plain white smock is required) are not permitted in arena until summoned by order of the Judge.

AMATEUR/OWNER TO RIDE- All riders in Amateur to Ride classes must have in their possession a current 2004 Amateur Certification Card issued by USEF (USAE), or make application for the card, at least one hour prior to riding in these classes. Applications may be secured through the Horse Show Secretary. Juniors are automatically considered amateurs (refer to USEF (USAE) Articles 808 and 809). Combined ownership is not allowed in Amateur-Owner Classes unless all owners are members of the immediate family. Leased horses are not eligible unless the lessee and lessor are members of the immediate family. **Horses entered in amateur owner must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF (USAE) Art 132.** (Horses registered in the farm, ranch, syndicate, partnership, or corporation name may be shown in Amateur Owner classes provided the family is the sole owner of the farm or entity as defined by USEF (USAE) Art 132. **The sale of a horse does not eliminate this registration requirement. (Contracts of Sale or Bill of Sale will not be accepted)**

CLASS CALLS / GATE HOLDS Will be made promptly. First, second and third calls will be broadcast in the barns and the warm-up rings at the proper times. The In-Gate will close two minutes after the first horse enters the ring. Gate holds will be permitted for exhibitors with back-to-back classes, if time permits and must be made with the Paddock Manager or Show Office.

Responsibility for entering classes on time rest with the exhibitor. In the event of a failure of the announcing system, it is still the exhibitors responsibility to be ready to enter the ring on time.

CAMPERS must be in designated areas only. Please check each show for appropriate fees. No gray water is to be discharged onto the ground.

DOGS see each show for rules.

DRIVING HORSES For safety purposes and to prevent accidents, driving horses will not be allowed into the holding ring until the class preceding theirs has entered the Coliseum/Show Ring. No other horses will be allowed in the holding area at this time.

FOOD will be available on the grounds.

FOOTING & RING SIZE

Coliseum 100' X 200' with a mix of sand and clay.

Coliseum Warm Up Ring 80' x 180' with sand.

Warm Up ring behind Main Horse barn 80' x 165' with stonedust.

4-H Ring (Dressage) 110' x 220' with sand & stonedust

4-H Warm Up Ring 90' x 200' with sand & stonedust.

Agway Arena 280' x 110" with stonedust.

West Springfield

Coliseum 100' X 200' with a mix of sand, wood chips and clay.

D Barn Ring 75' x 150' with stonedust.

Main Ring 140 X 300' with a mix of sand and loam.

Warm Up Ring 90' x 120' with sand & loam.

New Hampshire

Main Ring 150' X 250' with a mix of sand and soil.

IDENTIFICATION NUMBERS. Every horse in the show will be assigned an exhibitor number and this number must be worn by the exhibitor when the horse is being shown. Any exhibitor using the wrong number or not having a number may be excused or disqualified at the Judges discretion.

JUNIOR TO RIDE - Children eligible for Junior to Ride Classes shall not have reached their 18th birthday. For horse show purposes, the age of an individual on December 1st 2003 shall be maintained the entire year. Juniors are automatically considered amateurs.

LEAD LINE Exhibitors must be least two years of age and have not reached their 7th birthday. May not enter any other class at this show. The leader must be at least 14 years old, class will be judged, but not placed: **All exhibitors will receive the same awards.** Stallions not allowed. Exempt from AHA & USEF (USAE) membership requirements as long as they are in classes designated Lead line.

MAIDEN, NOVICE & LIMIT CLASSES

Horse/Rider Maiden, Novice, & Limit classes are open to horses which have not won one/three/six first place ribbons respectively, at a Regular Member Competitions of USEF (USAE) or the CEF in a particular performance section in which they are shown. This does not apply if a horse changes sections.

MANURE MUST be dumped in designated areas ONLY. Anyone found dumping into empty stalls, undesignated areas or on the grass, will pay an additional fee.

PARKING and UNLOADING Parking and unloading MUST be in designated areas only. All improperly parked vehicles will be towed away at owner's expense.

REFUNDS/VET SCRATCHES Full refund, less office fee before closing date. After closing date Vet certificate must be in the Show Secretary's hands before commencement of the show. Stalls fees, Office fees and 9-90 fees are NOT refundable. NO REFUNDS ONCE ON THE SHOW GROUNDS. In the case where a horse has been entered and not shown all fees will be forfeited.

PROFESSIONAL SERVICES Any professional service or consultation performed by the Show Veterinarian and/or Farrier for exhibitors outside the show ring will be upon a private fee basis. Vets phone number for after show hours will be posted at the show office

PROTECTIVE HEADGEAR All exhibitors in over fences and Hunt Seat Equitation classes must wear a helmet passing ASTM testing standards. ALL junior exhibitors riding anywhere on the grounds must wear protective headgear with harnesses buckled or they will be prohibited from riding anywhere other than the show ring. Adults are encouraged to comply with this safety rule. NYS requires parents or guardians to abide by the law requiring anyone under the age of 14 to wear a helmet. A law Officer can assess a fine to the parent or guardian not abiding by this law.

POST ENTRIES Please refer to each show for their policy.

SELECT AOTR, AAOTR, JOTR, JTR. (FORMERLY LIMITED) Open to rider/driver/handler that has not won AHA Regional Top 5, AHA National Top 10, or better in the corresponding class or any open class in the respective section. Riders in the Arabian, HA/AA Divisions shall not be considered separately when competing in the same performance section.

SCRATCHES The office must be notified if a horse does not intend to show in a class for which it has been entered. In the case where a horse has been entered and not shown, class fees will be forfeited. PLEASE SEE EACH SHOW FOR ADDITIONAL RULES

SHARPS/MEDICAL WASTE State rules will supersede USEF (USAE) sharps rule. Where applicable medical waste must be disposed of in marked containers, any needles etc, found in stalls will be subject to a \$100.00 fine.

SHOWING OUT OF TRAILER Refer to each show for rules and fees.

TBA CLASSES Please refer to the TBA Class List of each show

WARM UP RING There is to be no lunging or long lining in the warm up or holding ring when classes are in session.

WALK/TROT Open to Juniors 10 & under. May not enter any other performance class at this show. Stallions not allowed. Exempt from AHA & USEF (USAE) membership requirements as long as they are in classes designated a Walk/Trot.

ASSIGNMENTS OF STALLS IS ENTIRELY THE PREROGATIVE OF SHOW MANAGEMENT. Early entry is to the advantage of the exhibitor. Exhibitors wishing to be stabled together **MUST** send entries in the same envelope. Please see each show for stable request forms.

Box stalls have permanent doors. **NO INITIAL BEDDING IS PROVIDED.** Bedding must be ordered ahead of time – see each show for more information.

When Doing Your Entries

PLEASE TYPE or PRINT CLEARLY and ACCURATELY. This information is used to for programs and to process results, generates mailing labels, and used by the announcer. No horse may be entered on more than one entry blank.

Entry blanks containing illegible or omitted information will not be processed until the exhibitor in question has supplied Show Secretary with information required. Incomplete or illegible entry blanks will be returned at the owner's own risk.

SEND WITH YOUR ENTRIES

1. **PAYMENT IN FULL** Make checks/money orders payable to each show as per entry form. **Entries received with checks for partial payment, post dated checks, open checks or no payment will be treated as late entries and subject to late/post fee as outlined for each show.** Checks returned by the bank will be charged a NSF fee – see each show for amount.

2. **The complete and correct name and address of the registered owner must appear in the space entitled Owner Information.** One owner can appear on each entry form. (Owner is defined as the recorded owner as listed on the registration papers) Entries may be made in the name of a stable or farm only if (a) the stable or farm is a bona fide owner appearing on the horses papers, or (b) the stable or farm has been registered with USEF (USAE) and the number shown on the USAE certificate is noted in the space provided and certificate must be sent with the entries. Please refer to #4 below and AHA Membership section. It is suggested that additional copies of the entry blank (front & back sides) be made before filling in the blanks.

3. **SIGNATURES ALL SIGNATURES MUST BE ADULT** (18 or older). BOTH the Owner & Trainers signature lines must be signed, if there is no trainer the owner must sign the trainer line. In addition all **riders, handlers, drivers and Coaches (if applicable) must sign the entry blank.** Parent signing for junior and need not be a USEF (USAE) or AHA member, however they must write Parent next to their name. If applicable, the Minor Exhibitor Consent to Show section must be filled in and signed.

4. **PHOTO COPIES OF ALL REGISTRATION PAPERS (BOTH SIDES),** showing the registration number and ownership information. If the name shown on the registration papers is different from the person entering the horse, an affidavit, a copy of the sales contract or authorization form is required. In the case of a pending transfer / lease please refer to AHA Handbook article 1107. Photocopies of signed transfer are not proof of ownership. In owners classes Contracts of Sale or Bill of Sale will not be acceptable as proof of ownership.

5. **AHA Membership Cards** for every Owner, Trainer, Rider, Driver and Handler. Membership Affidavit will be available for those not having their cards with them with the exception of the Region 16 Championships. Adult signature is required on AHA affidavits. If a stable of farm name is used as owner, the stable or farm must have an AHA Farm/Ranch membership and that Farm/Ranch membership number must be used as the Owner AHA number. A copy of the Farm/Ranch membership card must be sent with the entries.

6. **USEF (USAE) Membership Cards** for every Owner, Trainer, Rider, Driver, Handler and Coach (if applicable). Membership Affidavit will be available at a fee of \$5.00 for those not having their cards with them.

7. USDF Membership Cards and Horse recording cards if applicable. **Membership Affidavit will be available at a fee of \$5.00 for those not having their cards with them.**

8. USEF (USAE) Amateur Cards for all riding in Amateur classes.

9. Copy of current negative Coggins test and proof of rabies if required.

BRING WITH YOU

HEALTH CERTIFICATES State law requires a health certificate for horses Traveling between state lines.

Rules common to all show grounds

THE FOLLOWING ARE RULES THAT APPLY TO ALL BARN
AND THE ENTIRE SHOWGROUNDS.

We hope common courtesy and common sense will prevail.
Remember safety is a primary consideration.

1. No smoking is allowed in the barns or in the coliseum.
2. Fireproof material must be used for all stall decorations, No live trees,(unless potted) wreaths, roping, etc.
3. The center Aisle of barns must remain clear.
 - a. Aisle displays are not to exceed: Main aisle – 30” from each side, side aisles- 24” from each side
 - b. No accumulation of litter or rubbish allowed.
 - c. All exits shall be kept free and unobstructed.
 - d. All fire lanes and other means of access for emergency vehicles shall be kept free and clear at all times.
 - e. All fire extinguishers, fire pulls and fire alarms stations shall be free and clear of obstructions and readily visible in their designated locations.
4. Bedding material and the like are not allowed on the floor of any aisle. This would include wood shavings, wet sawdust, peat moss, fine ground wood mulch, etc. large wood chips or coarse bark mulch may be used, but must be kept damp at all times. No coverings over aisles, which would in any way limit the effectiveness of the sprinkler system.
5. No graffiti in barns or stall. You will be billed for any type of damage.
6. Dogs must have current rabies vaccinations. Refer to each show for additional rules
7. No children are allowed on the rail in the coliseum.
8. No motorized vehicles of any type including bicycles, skateboards, roller blades, scooters, golf carts or mopeds are allowed in the barns, practice areas or any normal route used by horses. Any violation will result in the immediate impounding of the vehicle until the conclusion of the horse show.
9. No one under the age of 16 is permitted to drive a motorized vehicle on the grounds unless they have a permit or valid drivers license in accordance with the states registry of motor vehicle law. This regulation includes golf carts and mopeds.
10. All children 12 years and under must wear a helmet when riding a bicycle.
11. No rollerblading or skateboarding will be allowed on the Eastern States Exposition grounds.

Qualify in a show that was held in Region 16 within the preceding calendar year and that period of the current year prior to the commencement of the Regional Show

A 1st, 2nd, Region 16 Champion or Region 16 Reserve place must be obtained in the same AHA Section (i.e. Western, English, Hunter Pleasure are sections as listed in the AHA handbook)

A 1st thru 6th place in the following sections; Walk/Trot, Cutting, Working Hunter, Jumper, Park, Informal Combination and Pleasure Driving

Amateurs must be the rider to qualify for Amateur Classes. (JTR/AATR)
They can qualify in any class within the section they wish to show.

Owners must be the rider to qualify for Owner Classes (JOTR / AOTR / AAOTR)
They can qualify in any class within the section they wish to show.

Dressage can qualify in the same manor as above and also at USEF (USAE) Open Dressage shows for Training and First Level with two scores of 58% or better from two different Judges, Second & Third Level with two scores of 55% or better and Fourth Level and Prix St George one score of 50% or better. **Horses must be enrolled in the AHA Dressage Program.**

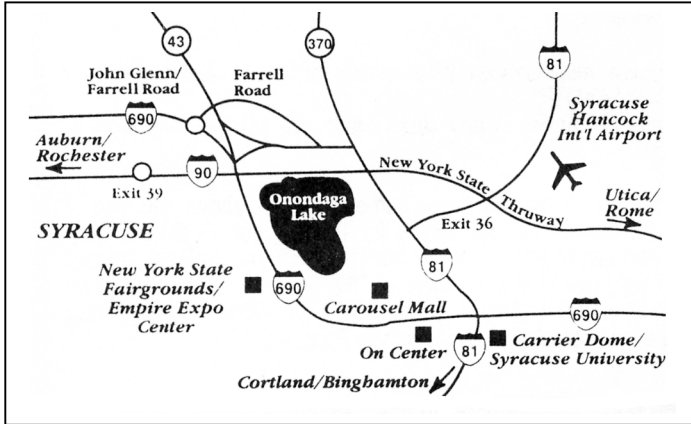

 From points South, follow interstate 81 North to Route 690 West and Exit 7 to the Fairgrounds.

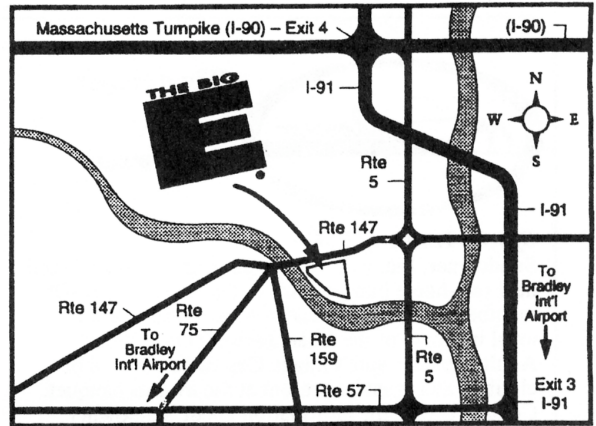

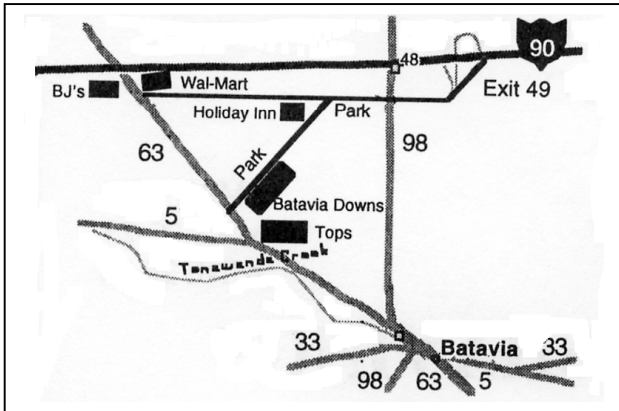

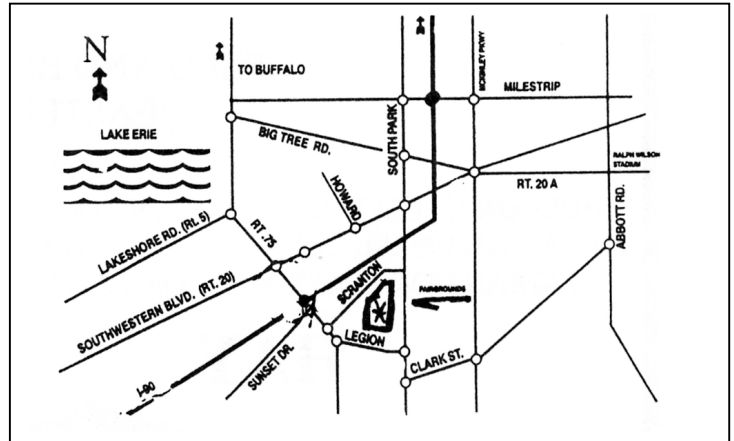
